

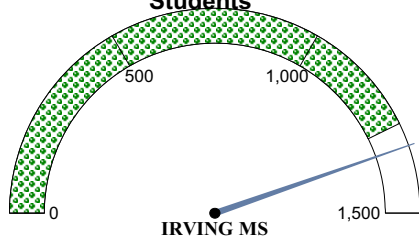

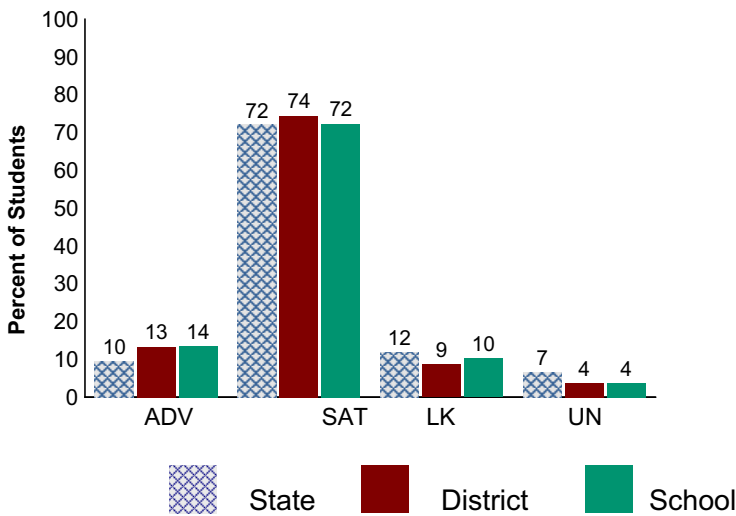

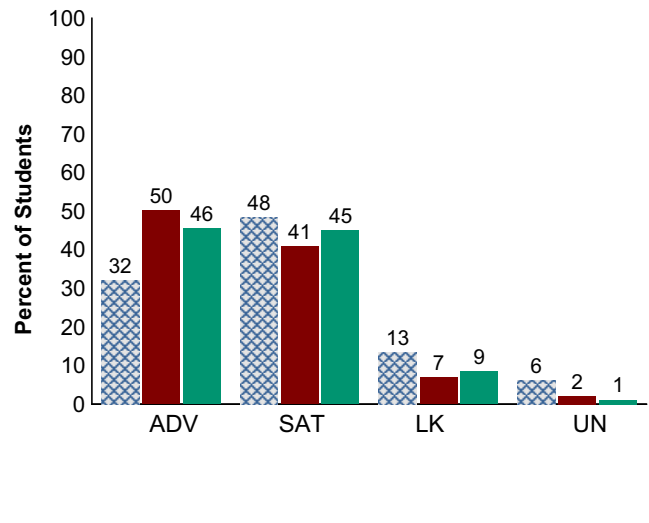

**State, District, and School Math Results**

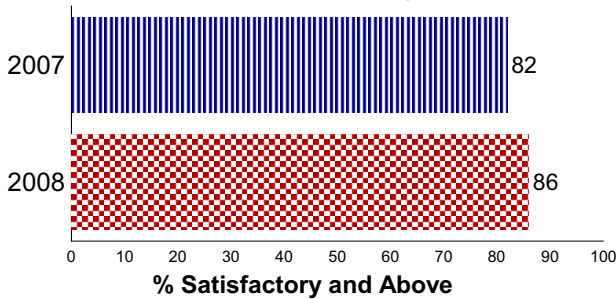

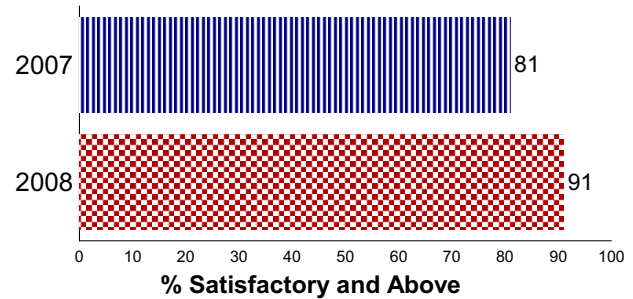

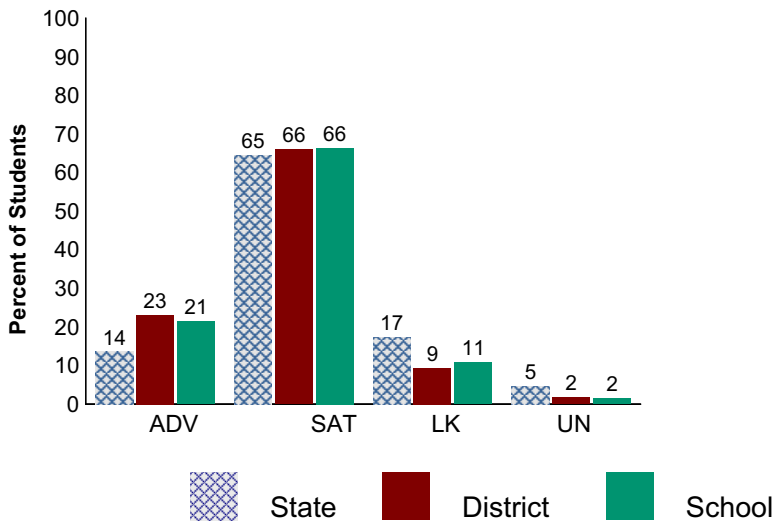

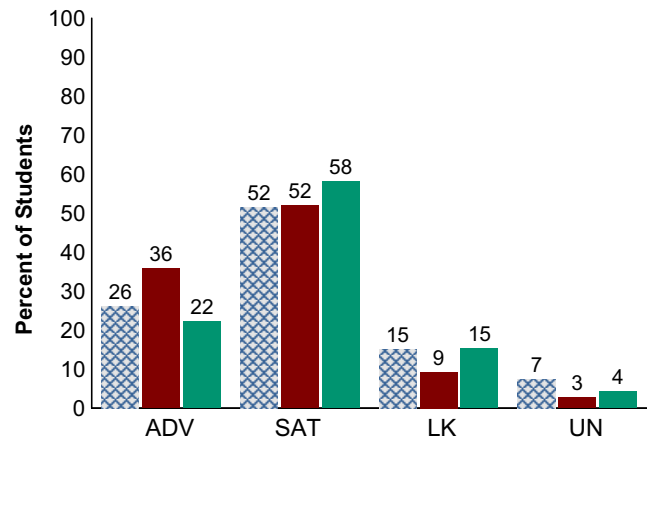

**State, District, and School Math Results**

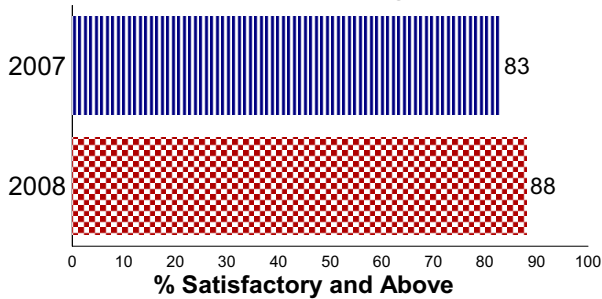

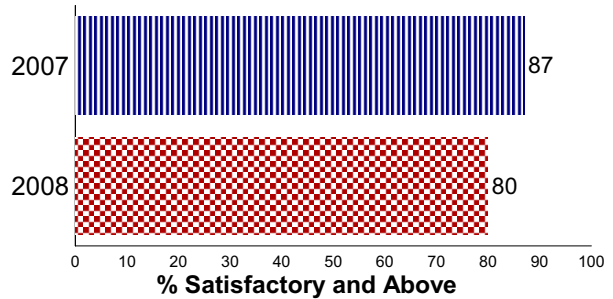

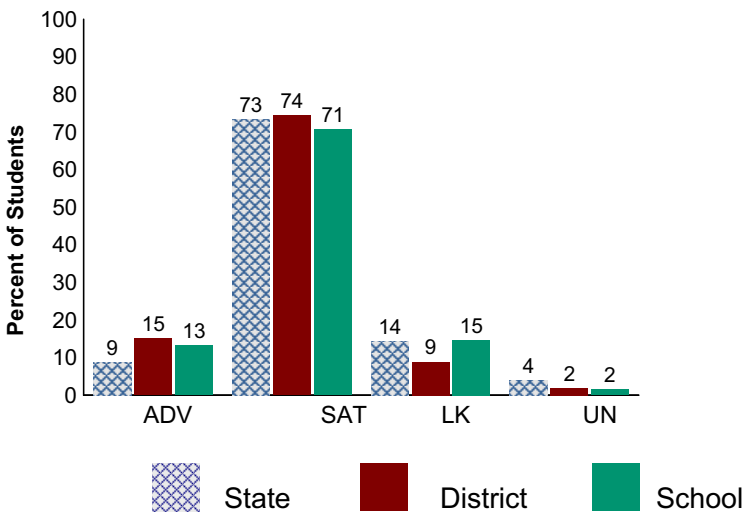

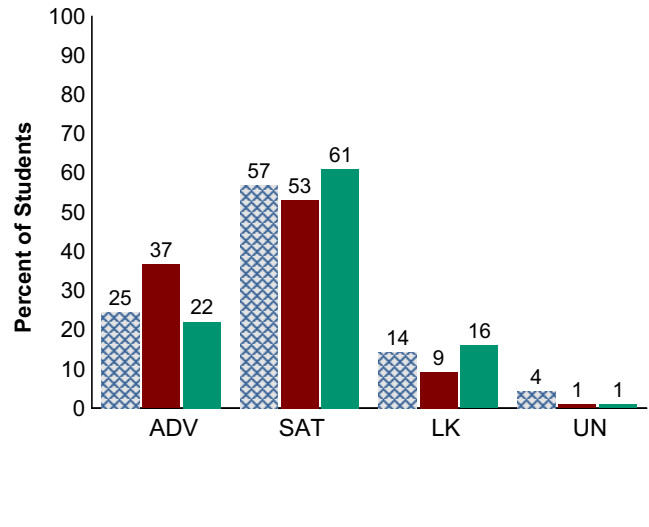

**State, District, and School Math Results**

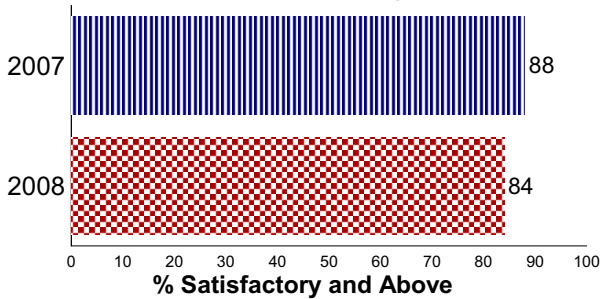

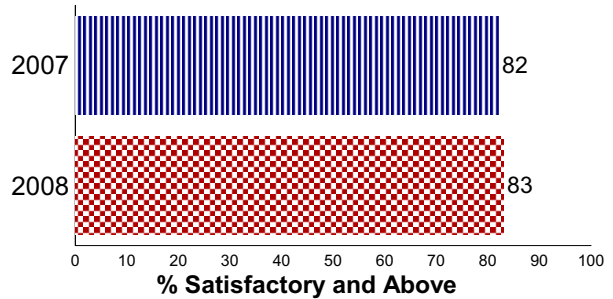
